3. 肯定願意作出環保承諾和監測其環境管理表現的參與企業




## About Hong Kong Green Awards (HKGA)

HKGA was first organized and staged by the Green Council in 2010 with the goal of formally identifying and recognizing local companies with exceptional performance on green purchasing and/or green management. The three core objectives of HKGA are:

1. Identify and recognize participating companies with outstanding performance and achievements in green purchasing, green management, environmental, health and safety management and green governance;
2. Encourage participating companies to increase environmental considerations and responsibility, as well as improve their environmental performances, in their management and operational processes; and
3. Determine participating companies that are willing to make environmental commitments and monitor their environmental management performances.
